### [Course Outline / Description]

This course discusses diverse ways in which Buddhism is practiced in contemporary contexts. It covers Buddhist stances on ethical issues such as meat-eating, abortion, and gender equality, as well as how Buddhism is practiced outside its traditional home of Asia, especially in the UK and the US. The course includes an examination of basic teachings and practices of Buddhism, with a focus on early/Theravada Buddhism.
