## [Course Outline / Description]

This course offers an introduction to the Japanese Constitution and landmark Supreme Court cases interpreting it. It explores the history of Japanese Constitution, its fundamental principles, and methods of constitutional interpretation in comparison with those of U.S. Constitution. Topics include the protection of fundamental human rights, nature and structure of the national government, and pacifism and national defense.

## Section 2

The students will be able to enhance their competency of logical thinking, and develop their presentation skill through analysis, briefing and presentation on actual precedents adjudicated by Japanese and U.S. Supreme Courts Justices, as well as understand basic constitutional frameworks of Japan in comparison with those of the United States.
