## The Politics of Reconciliation

#### [Course Outline / Description]

From the Nuremberg and Tokyo trials at the end of World War II, to truth commissions in East Timor and trials for the Khmer Rouge, nation-states have struggled to move forward after experiencing mass atrocities and war. How do nations heal from large scale tragedy? Can nations be collectively guilty for their pasts? How do victims and perpetrators restore justice? What does it mean to speak of reconciliation as a political process? This course investigates these issues and examines tools of reconciliation such as trials, apologies, truth commissions and reparations programs. The cases will focus particularly on the Asian region and include Japan's relations post World War II, Australia's apology to the aborigines, and other cases involving truth commissions and reparations. Attention is given to ongoing development of international law and institutions, domestic debates, and the role of nongovernmental actors, such as media and business.

## Section 2

- 1. Students learn theory, history and tools of political reconciliation processes (such as criminal trials, truth commissions and reparations).
- 2. Students understand and evaluate the tensions between justice, peace, truth, and mercy
  - and competing interests that arise in reconciliation processes.
- 3. Students can apply relevant components of political reconciliation to multiple issues and
  - cases, especially focused on the Asian region.
- 4. Students research current events related to the class and cases studied.
- 5. Students practice presentation skills and working with a group.
